- Tools can be implemented at the federal, state and/or local levels and by a number of entities. Some tools require legislation.
- Not every one of the tools in your handout is applicable to the Lower Dolores

Protection Tools: Water

State

Colorado In-stream Flow Program

- Voluntary
- Administered by the Colorado Water Conservation Board (CWCB)
- Several options (purchase or lease)
- Permanently protects stream flows

Protection Tools: Water

State

Colorado Laws and Inter-governmental Agreements

- Developed on a case-by-case basis
- Broad range of options for potential enactments and inter-governmental agreements
- Actions by a State Agency or Department
- Voluntary Flow Agreements
- Special Legislation (Colorado Legislature)

Protection Tools: Water

State

Other

- Gold Medal Waters: CDOW designation to recognize the highest-quality cold-water fishery habitats in the State
- Outstanding Waters: A Colorado Water Quality Control Act classification
- RICD or 'Recreational In-Channel Diversions' water right for recreational uses between two points (many stipulations)

Protection Tools: Water & Land

Federal

- USFS/BLM Land Management Plans: Land Management Plans establish broad guidance for the project and activity decision making needed to manage USFS and BLM lands; Overall plan and special area plans
- Wild and Scenic Rivers (requires federal legislation)
- Wilderness (requires federal legislation)
- Special designations: National Conservation Area; Research Natural Area; or Areas of Critical Environmental Concerns (require legislation)
- -- Other Special Legislation Targeted to a Specific Areas SUCH AS: Rio Grande National Area, South Platte Protection Plan, and the Rio Chama Management Plan (please refer to handout)

Protection Tools: Other

County and Local Efforts

- Conservation Easements on Private Land
- Local work projects (e.g. Tamarisk removal, river bank stabilization, cultural site stewardship programs)
- Land Stewardship Programs
- Local County Land Use Policy
- Local Contractual Agreements


